Supplement facts

Serving size: 1 film-coated tablet

One film-coated tablet contains:

Active substances: 600 mg alpha lipoic acid

Other substances: lactose monohydrate, hydroxypropyl cellulose, microcrystalline cellulose, croscarmellose sodium, povidone, sodium lauryl sulphate, colloidal silica anhydrous, stearic acid, talk and magnesium stearate.

Film: Opadry II yellow.

What is TIACID 600 and what is recommended for?

TIACID 600 is a dietary supplement, universal antioxidant that helps protect against cellular oxidation and age-related damage. Alpha Lipoic Acid (ALA) is a vitamin-like substance, universal antioxidant that helps glucose metabolism and energy production in the cells. It improves the function of peripheral nerves in patients with diabetic sensory polyneuropathy. Also supports liver function.

Mechanism of action:

Alpha lipoic acid prevents the formation of glucose in the blood vessels of matrix proteins, the formation of end products of glycosylation, endoneurally improves blood flow and stimulates the production of glutathione - the antioxidant substances. As a result of such action it improves the function of peripheral nerves in patients with diabetic sensory polyneuropathy.

Tiacid 600 (alpha lipoic acid) health benefits:

Directions for use:

One tablet daily on an empty stomach, preferable at least half an hour before the first meal. Do not exceed recommended daily dose.

Package: 30 film-coated tablets in a blister pack, in a box.

Storage instructions: Store below 25C in a dry place, out of reach of children.
