- 500 mg of glucomannan (Amorphophallus konjac root extract)
- 0.025 mg of chromium (as chromium picolinate)

# What Thinny is and what is recommended for?

**Thinny** is a dietary weight-loss supplement. It is recommended for weight management support.

#### Mechanism of action

**Glucomannan**, water-soluble dietary fiber in combination with chromium contributes to the reduction of body weight and supports healthy glucose and cholesterol levels, with beneficial effects on digestion.

On contact with water glucomannan particles swell and occupy a place in the stomach, and for that reason it is necessary to use it with plenty of water. It slows stomachs discharge and provokes a feeling of fullness (without flatulence and without unwanted gases in the digestive system), leading to reduced food intake. **Glucomannan** contributes to the reduction of body weight in the context of an energy-restricted diet. At least 3 g of glucomannan should be consumed daily in three doses of at least 1 g each, together with 1-2 glasses of water before meals, in the context of an energy-restricted diet. Also contributes to the maintenance of normal blood cholesterol levels (a beneficial effect is achieved by daily intake of 4 g glucomannan). Glucomannan has a probiotic effect, it helps rejuvenate the intestinal flora. It also helps in treating good bacterial intestinal flora. Maintains normal bowel function and healthy digestive system. It maintains the glucose and insulin ratio in the blood and can help reduce the glycemic index of meals.

**Chromium** contributes to the maintenance of normal blood glucose levels and normal macronutrient metabolism. It promotes fat and carbs metabolisam and helps weight loss.

#### Restriction for use:

Do not use this product if you are allergic to any of its ingredients.

#### Directions for use:

Two capsules, three times a day, half an hour before meal, with 1-2 glasses of water. Do not exceed the recommended intake.

# Caution

In people with difficulty in swallowing or in case of insufficient fluid intake there is a risk of choking. Therefore, it is imperative to take product with at least one glass of water (2dl) in order for capsules to reach the stomach. Excessive intake may have a laxative effect.

**Storage:** Store below 25 °C in a dry place, out of reach of children.
